Board of Trustees Regular Meeting Minutes of September, 22 2021 Training Room, 1020 West Algonquin Road Lake in the Hills, IL 60156

Call to Order. President Naatz called the meeting to order at 5:00 p.m.

Roll Call. Roll call was taken with the following results.

Present: Trustee/President Naatz, Trustee Black, Trustee Moss.

Absent: Trustee/Treasurer Markowitz, Trustee/Secretary Teson.

Others Present: Chief Kern, Deputy Chief Knebl, Attorney Joe Miller, and District Accountant James Howard.

Pledge of Allegiance/Moment of Silence. President Naatz led all present in the Pledge of Allegiance. President Naatz asked all attending for a moment of silence for fire service personnel who lost their lives in the line of duty since the last meeting on August 25, 2021.

Agenda Approval. Agenda approved as presented.

- COVID-19 Mandate MOU with Local 3985: The District met with Local 3985 and established the COVID-19 MOU. Staff is notifying the MOU has been implemented in line with the Executive Order.
- IGA with Village of Lake in the Hills: District Staff worked with the Village of Lake in the Hills to update the Plan Review IGA.

Motion by President Naatz, seconded by Trustee Moss, to approve IGA with Village of Lake in the Hills for Plan Reviews and Inspections. No discussion. Roll call vote: 3 Yes (Black, Moss, Naatz), 0 No, 2 Absent (Markowitz, Teson).

- Promotion to the Rank of Captain: Captain Pelinski has announced to the District of his retirement effective September 24th, 2021. With his retirement it has created an opening for a Lieutenant to be promoted to Captain.

- Promotion to the Rank of Lieutenant: Subsequent to the promotion of Lieutenant Kennedy to Captain there is a vacancy for Lieutenant. Staff seeks approval to promote from the current Lieutenant Eligibility Register.

Motion by Trustee Moss, seconded by Trustee Black, to approve the promotion of a firefighter to the rank of Lieutenant from the current Lieutenant Eligibility Register. No

- Replacement of Firefighter/Paramedic: District Staff recommends the replacement of a firefighter/paramedic spot for a member of the District who has resigned.

Motion by Trustee Moss, seconded by President Naatz, to approve the replacement of a firefighter/paramedic who has resigned. No discussion. Roll call vote: 4 Yes (Black, Moss, Markowitz, Naatz), 0 No, 1 Absent (Teson).
