

ORDINANCE NO. 2009- 06

**ORDINANCE LEVYING AND ASSESSING TAXES OF THE
ALGONQUIN-LAKE IN THE HILLS FIRE PROTECTION DISTRICT,
MCHENRY AND KANE COUNTIES, ILLINOIS FOR 2009**

BE IT ORDAINED by the Board of Trustees of the Algonquin-Lake in the Hills Fire Protection District, McHenry and Kane Counties, Illinois, as follows:

Section One: That the sum of **EIGHT MILLION THREE HUNDRED SIXTY-NINE THOUSAND SIX HUNDRED TWELVE DOLLARS AND NO CENTS (\$8,369,612.00)** be and the same is assessed and levied from and against all taxable property within the limits of the said Algonquin-Lake in the Hills Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2009, and which ordinance was duly published as provided by law, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

Section 2: That the Secretary is hereby directed to file certified copies of this ordinance with the County Clerks of McHenry and Kane Counties within the time specified by law.


Section 3: That this ordinance shall be in full force and effect from and after its passage and approval as required by law.




