

ORDINANCE NO. 2011- 04

**ORDINANCE LEVYING AND ASSESSING TAXES OF THE
ALGONQUIN-LAKE IN THE HILLS FIRE PROTECTION DISTRICT,
MCHENRY AND KANE COUNTIES, ILLINOIS FOR 2011**

BE IT ORDAINED by the Board of Trustees of the Algonquin-Lake in the Hills Fire Protection District, McHenry and Kane Counties, Illinois, as follows:

Section One: That the sum of **EIGHT MILLION FOUR HUNDRED FORTY THOUSAND ONE HUNDRED DOLLARS AND NO CENTS (\$8,440,100.00)** be and the same is assessed and levied from and against all taxable property within the limits of the said Algonquin-Lake in the Hills Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2011, and which ordinance was duly published as provided by law, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:




